Evaluation

Each module organizes a set of tests

- « Continuous assessment », and final exam (written, oral, report, participation...)
- One single grade is computed for each module
- elimination grade: 5/20

One grade per teaching unit (average of weighted modules' grades)

- TU grade >= 10/20, TU is validated
- TU grade < 10, TU is <u>not</u> validated

2nd (and last) session during summer





Retake exams aka « 2nd session »

Read your transcript and **anticipate** any retake exam (*1 possible retake per module per academic year*)

Make sure you are available for the exam session!

Respect carefully all due dates (report, defense, ...)





Assessment board

The assessment board is sovereign. Results are examined, and grades are validated. A decision is made:

- Award of the degree
- Retake session
- Retake all semester, or year
- Not permitted to proceed to the next stage of the degree course.

Disciplinary board:

- Whenever you break the rules
- Plagiarism
- Fraud





Year 3

In case of missing credits:

- The assessment board will require the semester/year retake
- For: all S5 modules, Master thesis, professional experience.

Other cases (quitus) :

- Award of your degree will be postponed, until all requirements are satisfied
- Maximum = 1 year.
- For: quitus « english », international, ...

Progression

- Supported by a new (*e-Learning platform*)
- Subject choice & approval
- Personal research + field stuty + methodl...
- Write according to your <u>tutor instructions</u>
- Tutor approval required prior to defense
- Defense is <u>mandatory</u>





Starting your master thesis

Some **regulations** to comply with:

- Your choice of a subject will allow us to find a supervisor
- Due time: end of <u>April</u> (1st session) or <u>June</u> (2nd session).

Guides & documents

- Guide: format requirements
- E-Learning platform: deliverables and due dates
- Evaluation sheet: assessment criteria

Max length per internship : 6 months





How to validate a prof. experience

EACH experience shall be assessed tage separately

School + company

Deliverables

- At least a « long internship » report (see « Guide du Stage Long »)
- Then, as many « simplified reports » as needed (one per experience).
 - Content: company, mission, results)

Prof'l Quitus validation

 At the end of the programme course, after all experiences examination.



Internships regulations (French Law)

Both number and length are limited:

The internship must be provisioned by the programme regulations For 3A: one internship (max. 6 months)

Other internship is not systematically possible!

Only if you do not reach the minimum required, or if you do not already have a « final » internship. Absolute deadline: Dec. 31st

Programme quitus

A quitus recognizes your compliance to a **mandatory programme requirement**

Quitus' list :

- English language: TOEIC, TOEFL or GMAT with minimal score.
- International : validated thanks to your semester in Nürnberg
- **Professional** : 9 months (*general case*)
- → <u>MyICN</u>: Prog. Grande Ecole Règlements / Règlement d'Examens du Programme ICN Grande Ecole / validation des Quitus International et Professionnels

Anticipating quitus validation

English language

- Make sure you can register for an exam session.
- Send the transcript to the registrar

International, and Professional

Make sure your tutor has got all required documents to validate quitus
