Integration in PGE2/PGE3 (alternance): 6 months of prof. Experience, counting only weeks spent in companies

Specific arrangements:

(CCA) C.C.A. internship (2 to 4 months possible). Minimum = 6 months

(M2 Droit + PGE3) End of CGM internship + PGE3 = 9 months possible. Minimum = 6 months

(D.U. Droit) End of PGE22, M2, PGE3+ = 9 months possible. Minimum = 6 months

(D.D. sans A/E) End of PGE2 & PGE3 internships = 9 months possible. Minimum = 6 months

INTERNATIONAL QUITUS - validation procedures

General case: - Academic stay in partner university (a least one semester)

- Long professionnal experience abroad (>= 5 months)
- ICN Certificate in Berlin or Chengdu
- GICC Certificate Global Int'l Competency Certificate

Exemptions: - Uninterrupted apprenticeship for the whole of PGE2 and PGE3 for student who have entered PGE2 directly

- Uninterrupted double degree course for the whole of PGE2 and PGE3 for student who have entered PGE2 directly
- Foreign student, on presentation of an identity card or passport
- Foreign student coming to study in France
